Established in 2003 The Christchurch Farmers' Market is New Zealand's premier Farmers' Market, created from a desire to easily serve local, seasonal ingredients and produce to the people of Christchurch. The market has grown from 10 stalls to now over 80 stalls. Some of the original stall holders from the beginning are still with us today.

Set in the stunning grounds of Riccarton House and Bush, the Farmers' Market runs every Saturday from 9am until 1pm all year round. With the best of Canterbury's produce on offer, Hummingbird coffee and live music, the market is a must-do every week. Internationally recognised the Lonely Planet lists the Christchurch Farmers' Market on their "Things to do in Christchurch" list.

The market is widely acclaimed for both the quality and diversity of its fresh farm products, and artisan and prepared foods. It is renowned throughout the country as one of the top farmers markets to visit. We aim to make sure that the actual stallholders are the producers themselves – people who grow, rear or bake the food that they sell.

Trade is only by successful application to the Market Management through the Application to Trade form and subject to Market Management's approval. To ensure the successful running's and the requirement with Health & Safety regulations at the market, a range of Terms and Conditions must be complied with at any time when trading at the market. By signing the Application to Trade, you are agreeing to comply with the current Terms and Conditions and the Code of Conduct, should your application be successful. The Terms & Conditions and the Code of Conduct are subject to a yearly revision. If you wish to sell processed food, you will be required to comply with all relevant national food safety regulations. If your Application to Trade is accepted, it is subject to your successful submission and compliance with the Christchurch City Council Food Safety Registration for Food Vendors. If you are going to sell alcohol (off-premise only) you will need to apply for a Special Licence from the Christchurch City Council. Once approval has been granted, a copy of your approval(s) must be submitted to Christchurch Farmer's Market, Market Manager, 16 Kahu Road, Christchurch prior to commencing trading at the market or given to the Market Manager on your first day of trading at the
